

# CHINA COTTON MARKET REPORT

#### March 2016

SUBJECT	Key Findings			
Cotton Market	a) Imports			
	In February, China imported 56,231 MT of cotton, a decrease of 41.17 percent month-on- month (m/m), and a decrease of 64.66 percent year-on-year (y/y).			
	The total value of cotton imports in February was USD 99.25 million, a decrease of 37.39 percent m/m and a decrease of 63.26 percent y/y.			
	The U.S. was ranked as the second largest cotton supplier to China in February. Uzbekistan was ranked as the first:			
	• U.S. Imports: 11,918 MT, representing an increase of 17.36 percent m/m, and a decrease of 72.06 percent y/y. U.S. cotton imports accounted for 21.19 percent of the total quantity imported to China in February.			
	• Uzbekistan Imports: 21,105 MT, representing a decrease of 33.55 percent m/m and a decrease of 35.53 percent y/y. Uzbekistan cotton imports accounted for 37.53 percent of the total quantity imported to China in February.			
	• Indian Imports: 5,500 MT, representing a decrease of 70.20 percent m/m and a decrease of 88.06 percent y/y. Indian cotton imports accounted for 9.78 percent of the total quantity of imported cotton to China in February.			
	By the end of February, Chinese cotton imports totaled 151,812 MT, a decline of 52.61 percent y/y. U.S. cotton was ranked as the fourth with a total quantity of 22,073 MT, accounting for 14.54 percent of total imports. Uzbekistan was ranked as the largest supplier with a total quantity of 52,869 MT, accounting for 34.83 percent of total imports. India was ranked as the second with a total quantity of 23,952 MT, accounting for 15.78 percent of total imports.

	b) 2016 China Cotton Situation			
	According to the China Cotton Association (CCA)'s latest survey, the intended plantation acreage for 2016 increased slightly compared to the previous survey done by CCA of this type due to the second group of subsidies. In mid-March, the National Development and Reform Commission (NDRC) published the 2016 target price for Xinjiang cotton which is RMB 18,600 per MT, RMB 500 lower than in 2015.			
	Cotton enterprises strengthened sales efforts while current prices for cotton declined by a considerable margin. Due to the influence of the Chinese New Year, domestic cotton textile market remains depressed. Exports of textile and apparel witnessed a sharp decline in			

February, as did cotton imports to China.



SUBJECT	Key Findings				
		During the CCA Cotton Situation Analysis Meeting in March, relevant government agencies expressed that the auction of reserved cotton will be conducted on a regular basis. The volume to be auctioned will be based on the market situation. The first auction this year will be scheduled in late April. Considering that enterprises need high quality cotton, the imported cotton in the reserve will be auctioned on the market in the first place.

		In February, the average price of imported cotton was 1,765 USD /MT, an increase of 6.43 percent from the previous month. Average prices for cotton from the United States of America and India were:			
		U.S. cotton: USD 2,378 /MT, an increase of 5.04 percent m/m;			
		Indian cotton: USD 1485 /MT, an increase of 1.72 percent m/m.			
		Domestic Cotton:			
		The February <i>CC index 2129B</i> average price was RMB 12,846/MT (USD 1,967/MT), a decrease of 2.99 percent m/m.

		The March <i>CC Index 2129B</i> price decreased from RMB 12,633/MT (USD 1,932/MT) on March 1 <sup>st</sup> to RMB 12,228/MT (USD 1,877/MT) on March 24 <sup>th</sup> .

Textile	a)	Synthetic Fiber Production			
Industry		According to the National Bureau of Statistics (NBS), synthetic fiber production for January and February reached 701.8 MMT, an increase of 3.7 percent y/y.			
	b)	Textile and Apparel Exports			
		According to the General Administration of Customs (GAC), China's textile and apparel exports for February totaled USD 15.66 billion, a decrease of 35.11 percent m/m, and a decrease of 27.76 percent y/y. By the end of February, China's textile and apparel exports totaled USD 39.79 billion in 2016, a decrease of 15.73 percent y/y.			
		Textiles accounted for USD 6.08 billion of total exports, representing a decrease of 35.63 percent m/m and a decrease of 27.56 percent y/y; apparel accounted for USD 9.58 billion, a decrease of 34.78 percent m/m, and a decrease of 27.89 percent y/y.

	Xi'an, China. The theme of AE20 is Innovation, Cooperation and Sustainable Agricultural Investment (provisionally identified). AE20 aims to create an enabling political and commercial environment for G20 agricultural investment, build a platform for business dialogue and let enterprises play their role in improving agricultural trade, and economic development and promoting common prosperity in agriculture. Around 200 participants from influential agricultural enterprises in G20 Member States, international organizations and relevant international financial, investment and consulting agencies such as FAO, UNCTAD, World Bank, and OECD will be invited.			
	We hold that this is a high level and multilateral platform for the discussion and communication of relevant agricultural development and investment policies with government officials and peers of G20 countries. If the US cotton industry is interested in attending the forum, please nominate a list of proposed participants by March 5th. YA will transfer it to the Secretariat of the forum.



#### Chart 1: March 2016 China Cotton Imports by Country of Export (Quantity)







