# Monday, September 9, 2024

- The Farm Foundation will discuss "The Agricultural Platforms of the Candidates for President of the United States."
- The U.S. Census Bureau will release its Monthly Wholesale Trade: Sale and Inventories report.
- The Board of Governors of the Federal Reserve System will release its Consumer Credit report.
- China will release its Consumer Price Index and Producer Price Index.
- USDA-National Agricultural Statistics Service will release its Crop Progress report.

## Tuesday, September 10, 2024

- The House Energy and Commerce Subcommittee on Health will hold a hearing on "Evaluating FDA Human Foods and Tobacco Programs." Key witnesses include Jim Jones, Deputy Commissioner for Human Foods, FDA, and Dr. Brian King, Director, Center for Tobacco Products, FDA.
- The House Financial Services Subcommittee on Digital Assets, Financial Technology, and Inclusion will hold a hearing on "Decoding DeFi: Breaking Down the Future of Decentralized Finance."
- The House Financial Services Subcommittee on Oversight and Investigations will hold a hearing on "The Fall of ESG: Scrutinizing the Failed Use of Environmental, Social, & Governance Standards and the Influence of Proxy Advisors."
- Vice President Kamala Harris and former President Donald Trump will square off in a presidential debate in Philadelphia. The rules for the event, hosted by *ABC News*, will largely mirror the terms used by *CNN* for its June 27 debate, including that microphones will be muted as the other candidate speaks and no studio audience will be present, according to the network, noting that both candidates had agreed to the format.
- China will release its first batch of trade figures for August, including soybeans, edible oil, and more.

#### Wednesday, September 11, 2024

- The House Transportation and Infrastructure Subcommittee on Water Recourses and Environment will hold a hearing on "Waters of the United States Implementation Post-Sackett Decision: Experiences and Perspectives."
- The House Appropriations Subcommittee on Agriculture, Rural Development, Food and Drug Administration, and Related Agencies and House Agriculture Subcommittee on Nutrition, Foreign Agriculture, and Horticulture Oversight will hold a joint hearing on "Severe Food Distribution Shortages in Tribal and Elderly Communities."
- The House Energy and Commerce Subcommittee on Energy, Climate, and Grid Security will hold a hearing on "From Gas to Groceries: Americans Pay the Price of the Biden-Harris Energy Agenda."



- The House Financial Services Subcommittee on Financial Institutions and Monetary Policy will hold a hearing on "Transparency in Global Governance."
- The Bureau of Labor Statistics will release its Consumer Price Index report.

## Thursday, September 12, 2024

- The Senate Finance Committee will hold a hearing "To Examine the 2025 Tax Policy Debate and Tax Avoidance Strategies."
- The Farm Credit Administration will hold a meeting of the quarterly report on economic conditions and Farm Credit System condition and performance.
- The European Central Bank will announce its decision on interest rates. ECB President Christine Lagarde will address the media following the announcement.
- The U.S. Department of Labor will release its Jobless Claims report.
- The U.S. Bureau of Labor Statistics will release its Producer Price Index report.
- The Bureau of the Fiscal Service will release its Monthly Treasury Statement.
- The Federal Reserve will release its Balance Sheet and Money Supply reports.
- The U.S. Bureau of Labor Statistics will release its U.S. Import and Export Price Indexes Summary report.
- The University of Michigan will release its Consumer Sentiment report.
- USDA-Foreign Agricultural Service will release its Weekly Export Sales, Cotton, Grain, Oilseed: World Markets and Trade, and World Agricultural Production reports.
- USDA- National Agricultural Statistics Service will release its Cotton Ginnings and Crop Production reports.
- China's agricultural ministry (CASDE) will release its monthly report on supply and demand for corn and soybeans.
