- The House Rules Committee will meet to formulate a rule on H.J.Res. 87 regarding disapproval of the Environmental Protection Agency's (EPA) "Heavy-Duty Vehicle and Engine Emission Warranty and Maintenance Provisions" rule, H.J.Res. 88 regarding disapproval of the EPA's "Advanced Clean Cars II" rule, and H.J.Res. 89 regarding disapproval of the EPA's "Omnibus Low NOX Regulation" rule.
- The Senate will meet to resume consideration of David Perdue's nomination to be the U.S. ambassador to China, and they will vote on a motion to invoke cloture on the nomination.
