### Monday, February 23, 2026

- Federal Reserve Bank Governor Christopher Waller will speak at the 2026 National Association for Business Economists Annual Economic Policy Conference in Washington, D.C.
- The Senate will vote on a motion to invoke cloture on the motion to proceed to H.R. 7147, “Making further consolidated appropriations for the fiscal year ending September 30, 2026.”
- EU foreign ministers will meet in Brussels to discuss Russia’s war against Ukraine.
- The People’s Bank of China will announce its interest rate decision.

- President Trump will deliver the State of the Union Address to Congress. Following the address, Governor Abigail Spanberger (D-VA) will deliver the Democratic response.
