



## Events for the Week of April 27 – May 1, 2026

### Monday, April 27, 2026

- President Trump will participate in events for the arrival of King Charles III, the King of the United Kingdom of Great Britain and Northern Ireland and Queen Camilla at the White House.
- The House Appropriations Committee Interior, Environment, and Related Agencies Subcommittee will hold a hearing on “Budget Hearing - Environmental Protection Agency.” Environmental Protection Agency Administrator Lee Zeldin will testify.
- The Export-Import Bank will hold a meeting to discuss U.S. content change for the Working Capital Guarantee Program.
- The House Rules Committee will meet to formulate a rule on H.R. 7567, the “Farm, Food, and National Security Act of 2026,” also known as the farm bill.
- The Supreme Court will hear arguments in *Monsanto Co. V Durnell*.
- The Central Bank of Chile will announce its interest rate decision.
- The Bank of Japan will announce its interest rate decision.

### Tuesday, April 28, 2026

- The U.S. Trade Representative will hold a hearing on the initiation of Section 301 investigations of acts, policies, and practices of various economies related to the failure to impose and effectively enforce a prohibition on the importation of goods produced with forced labor.
- The Federal Open Market Committee will begin its two-day closed meeting to discuss monetary policy and set interest rates.
- The Senate and the House will hold a joint meeting to receive an address from King Charles III, the King of the United Kingdom of Great Britain and Northern Ireland.
- The House Energy and Commerce Environment Subcommittee will hold a hearing on “The FY2027 Environmental Protection Agency Budget.” Environmental Protection Agency Administrator Lee Zeldin will testify.
- The Senate Foreign Relations Committee will hold a hearing on the nomination of Darrell Owens to be U.S. representative to the Organization for Security and Cooperation in Europe.
- The Export-Import Bank (EXIM) will hold a meeting of the 2026-2027 EXIM Advisory and Sub-Saharan Africa Advisory Committees for discussion of EXIM policies and programs designed to support the expansion of financing support for U.S. manufactured goods and services.
- The Magyar Nemzeti Bank will announce its interest rate decision.

### Wednesday, April 29, 2026

- The Texas Cotton Association (TCA) will hold its TCA 115<sup>th</sup> Anniversary Convention through Friday in College Station, TX.
- Federal Reserve Board Chairman Jerome Powell will hold a news conference following a Federal Open Market Committee meeting, where he will announce its interest rate decision.
- The House Appropriations Committee will hold a markup of the FY2027 Agriculture, Rural Development, Food and Drug Administration, and Related Agencies bill.



- The House Financial Services Committee’s Task Force on Monetary Policy, Treasury Market Resilience, and Economic Prosperity will hold a hearing on “Examining Derivatives’ Role in the Treasury Market.” Witnesses include: Mr. Kevin McPartland, Head of Research for Market Structure and Technology for Crisil Coalition Greenwich; Mr. Terrence A. Duffy, Chairman and Chief Executive Officer of CME Group; Mr. Jeff Cranston, Head of Corporate Strategy for Optiver; and Professor Yesha Yadav, Professor of Law and Associate Dean at Vanderbilt University Law School.
- The Senate Environment and Public Works Committee will hold a hearing on “The U.S. Environmental Protection Agency’s Proposed FY2027 Budget.” Environmental Protection Agency Administrator Lee Zeldin will testify.
- The Senate Banking, Housing and Urban Affairs Committee will hold an executive session to consider Kevin Warsh’s nomination to be chairman of the Board of Governors of the Federal Reserve.
- The Bank of Namibia will announce its interest rate decision.
- The Bank of Thailand will announce its interest rate decision.
- The Central Bank of Brazil will announce its interest rate decision.
- The Bank of Canada will announce its interest rate decision.

#### **Thursday, April 30, 2026**

- The U.S. Chamber of Commerce will hold a 2026 Health Summit, with the theme “America’s Health Advantage.” Health and Human Services Secretary Robert F. Kennedy, Jr. will participate in a discussion on “Consumer Priorities, Administration Perspectives.”
- The Senate Foreign Relations Committee will hold a markup to vote on the nominations of Fleet White to be an assistant secretary of State for political and military affairs; Todd Steggerda to be representative of the U.S. to the Office of the United Nations and other international organizations in Geneva; Preston Wells Griffith III to be representative of the United States to the Vienna Office of the United Nations and to be representative of the United States to the International Atomic Energy Agency; and Frank Garcia to be a member of the board of directors of the African Development Foundation.
- The Bank of Botswana will announce its interest rate decision.
- The National Bank of Ukraine will announce its interest rate decision.
- The Bank of England will announce its interest rate decision.
- The European Central Bank will announce its interest rate decision.
- The Bank of the Republic of Colombia will announce its interest rate decision.
